To strengthen the preparedness of law enforcement officials from the MENA region in identifying and combating the dissemination of terrorist and extremist content online, the EU Knowledge Hub on Prevention of Radicalisation is organising the online training “Monitoring terrorist content online (TCO) and violent extremism: a MENA-focused approach” to enhance participants’ knowledge and skills in this area.

The course is designed for beginners and practitioners, including MENA law enforcement officials and professionals working on online terrorist content or managing platforms vulnerable to extremist propaganda.



WHAT WILL YOU LEARN

By the end of this training, participants will be able, among other, to:

- Identify current trends and emerging threats related to radicalisation and violent extremism in the MENA region
- Understand the concept and issues associated with Terrorist Content Online (TCO)
- Interpret regulations and strategies on content moderation that may be adapted by MENA countries in EU–MENA partnership
- Present preventive and counter measures against TCO
- Implement cross-sector collaboration to address online terrorist content and violent extremism, including recruitment, communication of TCO and targeting of vulnerable individuals

TRAINING CONTENT OVERVIEW

The training will cover:

- Types and trends of radicalisation and violent extremism in the MENA region
- Online dissemination of Terrorist Content and related issues, including recruitment and propaganda, radicalisation of individuals, and planning of terrorist attacks
- Use of digital platforms by terrorist groups and manipulation techniques
- Preventing and countering TCO through legal frameworks, international cooperation, and cross-sector collaboration
- EU TCO Regulation and international content moderation standards



ELIGIBILITY AND SELECTION CRITERIA

To be eligible, applicants must:

- Have less than 3 years of professional experience in monitoring or countering online terrorist content, radicalisation, or violent extremism
- Be a citizen of a Middle East and North Africa country, EU Member State, a Western Balkan country, or partner third countries (e.g., UK, Norway, Iceland)
- Work in law enforcement, digital monitoring, or countering online violent extremism in the MENA region. (Note: Priority will be given to candidates with relevant professional experience in these areas)
